As part of the American Rescue Plan due COVID-19 pandemic, Los Angeles Pacific University has received Higher Education Emergency Relief Fund III (HEERF III) funds to disburse to its students. The Department of Education has established the following criteria for distribution of HEERF III funds:

- No longer require that a student be eligible to receive Title IV financial aid funds (as with HEERF II), be a citizen or domestic student
- Must prioritize students who are considered to be of exceptional need, defined by LAPU to include:
 - All students enrolled in the Summer 1 2021 session
 - All Pell eligible students enrolled during the COVID-19 national emergency declaration period

Based on this criteria you are eligible to receive the HEERF III funds. We anticipate these funds to be awarded to you in August.

You can request to have your funds sent to you via direct deposit. Please follow the instructions below on how to set up direct deposit.

If you have not done so already, please sign up for Direct Deposit by: **August 16, 2021**

If you do not sign up for direct deposit you will have your funds sent to you to the most recent mailing address we have on file.

PLEASE NOTE: If funds go uncashed for a reasonable period of time, you could have your grant funds rescinded.

If you have a prior owing balance with LAPU, we will send you a separate email linking to an authorization form letting us apply these funds to your prior account balance.

3. If you choose **NO** the aid will go directly to you either via check or bank account. Please ensure you have completed the process to sign up for direct deposit. We will reach out to follow up on any unresolved balance.

PLEASE NOTE: The deadline to have this form completed is August, 22nd, 2021. If you do not authorize us to use these funds for a prior balance, these funds will be sent to you via direct deposit (if you have signed up) or mailed to the address we have on file.

The U.S. Department of Education announced an additional \$21.2 billion is now available to higher education institutions to ensure learning continues for students during the COVID-19 pandemic under the CRRSAA as HEERF II.
