The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under all emergency funds total \$76.2 billion.

Los Angeles Pacific University hereby acknowledges that the institution signed and returned the Certification and Agreement form providing assurance that the institution has used, or intends to use, no less than the required amount of funds received to provide HEERF grants to students totaling \$954,744 awarded on June 23, 2021.

Students eligible to receive a HEERF III grant were notified of a refund. Those eligible students with an account balance owed to the institution were asked to provide authorization for applying any or all grant funds to the existing balance. The Higher Education Emergency Relief Fund II (HEERF II) is authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260, signed into law on Dec. 27, 2020. In total, the CRRSAA authorizes \$81.88 billion in support for education, in addition to the \$30.75 billion expeditiously provided last spring through the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136.

Those eligible students with an account balance owed to the institution were asked to provide authorization for applying any or all grant funds to the existing balance. Re-awarding of Uncashed Checks

Summary

Los Angeles Pacific University made concerted and reasonable efforts to reach students with uncashed, stale HEERF II and III funding checks. After this effort was conducted, it was determined that a total of \$53,221.28 (\$8,658.60, 15 checks HEERF II / \$44,562.68, 113 checks HEERF III) was deemed uncashed and available for redistributing to eligible students.
